MATERIAL AT THE LBJ LIBRARY PERTAINING TO FOREIGN INTELLIGENCE

INTRODUCTION

This list includes the principal files in the Johnson Library that contain material specifically relating to foreign intelligence. It is not definitive, however, and researchers should consult with the Library's archivists about other potentially useful files. For example, most intelligence reports received by the White House were filed by topic and will be found in the files related to that topic. Unless otherwise noted, the files listed in this guide have been processed and are available for research. .

See also the Library's guide "The F.B.I., J. Edgar Hoover, Surveillance and Privacy.

Researchers may also want to consult the *Foreign Relations of the United States* series before conducting research at the Johnson Library. This multi-volume documentary history is the official record of U.S. diplomatic activity. The volumes contain many documents from the holdings of the Johnson Library. The published volumes are available on-line at the State Department's web site at <http://www.state.gov/r/pa/ho/frus/johnsonlb/>, and you can also reach that site through the "Related Links" section of the Johnson Library web site (<http://www.lbjlib.utexas.edu>) under the "Research" button. Bound volumes may be available at any major university or public library. *Volume XXXIII, Organization and Management of U.S. Foreign Policy; United Nations* contains a large section on the Intelligence Community.

WHITE HOUSE CENTRAL FILES (WHCF) and CONFIDENTIAL FILE

This permanent White House office was the main filing unit during the Johnson presidency, though not the primary file for foreign policy documents. Material was filed under 60 major subject headings, several of which are pertinent to foreign intelligence.

NATIONAL SECURITY FILE

This file was the working file of President Johnson's special assistants for national security affairs, McGeorge Bundy and Walt W. Rostow. Documents in the file originated in the offices of Bundy and Rostow and their staffs, in the various executive departments and agencies, especially those having to do with foreign affairs and national defense, and in diplomatic and military posts around the world. More than one-half of the National Security File has been processed. Consult the finding aid in the Reading Room or borrow a lending copy by writing to the Supervisory Archivist, LBJ Library, 2313 Red River Street, Austin, Texas 78705. Those folders whose titles are preceded by an asterisk "*" or a date have been processed and their contents declassified in whole or in part. Lists of classified documents have been placed in those folders, and you may request mandatory review of individual documents that have not yet been declassified in full. Those folders not preceded by an "*" or a date are unprocessed and are not subject to mandatory declassification review. Consult with a member of the staff on the processing schedule.

As noted above, most intelligence reports were filed in the files related to the topic of the intelligence report, not in these files.

JOHN MCCONE MEMORANDA

This collection, part of the Papers of Lyndon B. Johnson, consists of notes of sixty-eight presidential meetings attended by Director of Central Intelligence John McCone between November 23, 1963, and McCone's resignation on April 28, 1965. In addition, there are notes for four presidential meetings that one or more of McCone's key aides attended in his stead. The entire collection is processed and is contained in one box.

RECORDS OF THE CENTRAL INTELLIGENCE AGENCY

2 feet of textual records and 378 rolls of microfilm open, 19 rolls of microfilm closed; open material consists of Foreign Broadcast Information Service (FBIS) Daily Reports containing selections from foreign broadcasts and press reports, 1963-69.

ORAL HISTORY COLLECTION

Transcripts of oral history interviews may be consulted at the Library or borrowed by mail by writing to the Interlibrary Loan Archivist, Lyndon Baines Johnson Library, 2313 Red River Street, Austin, Texas 78705. Transcripts of some interviews are also available on the Johnson Library web site and most transcripts are available on the University of Virginia's Miller Center web site. Interviews with the following people contain material on Foreign Intelligence and are open for research. Additional interviews will be opened on a regular basis. Interviews marked (WP) require written permission. Contact the Interlibrary Loan Archivist regarding the procedure.

RECORDINGS AND TRANSCRIPTS OF TELEPHONE CONVERSATIONS

The collection includes over 6,000 recordings of President Johnson's telephone conversations with members of Congress, other public officials, foreign leaders, members of the press, friends and family. A detailed, searchable finding aid, including descriptions of individual conversations, is available on the Johnson Library web site, as is information about purchasing copies of the recordings. Researchers may also listen to the recordings on the University of Virginia's Miller Center Presidential Recordings web site.

NSC INTELLIGENCE RECORDS

These records relate to the Special Group 5412 and the 303 Committee during the Johnson administration. They remain in the physical custody of the NSC pending declassification, but researchers may request access to them under the Freedom of Information Act.
